This notice is to inform you of INR's intent to submit an application for coverage under the Pennsylvania Department of Environmental Protection (PADEP) Permit to Drill and Operate an Unconventional Gas Well in Springhill Township, Fayette County, Pennsylvania. This application will be submitted for the Coastal 4H well, located at 2444 Springhill Furnace Road, Lake Lynn, PA 15451 off the Coastal Well Pad.
