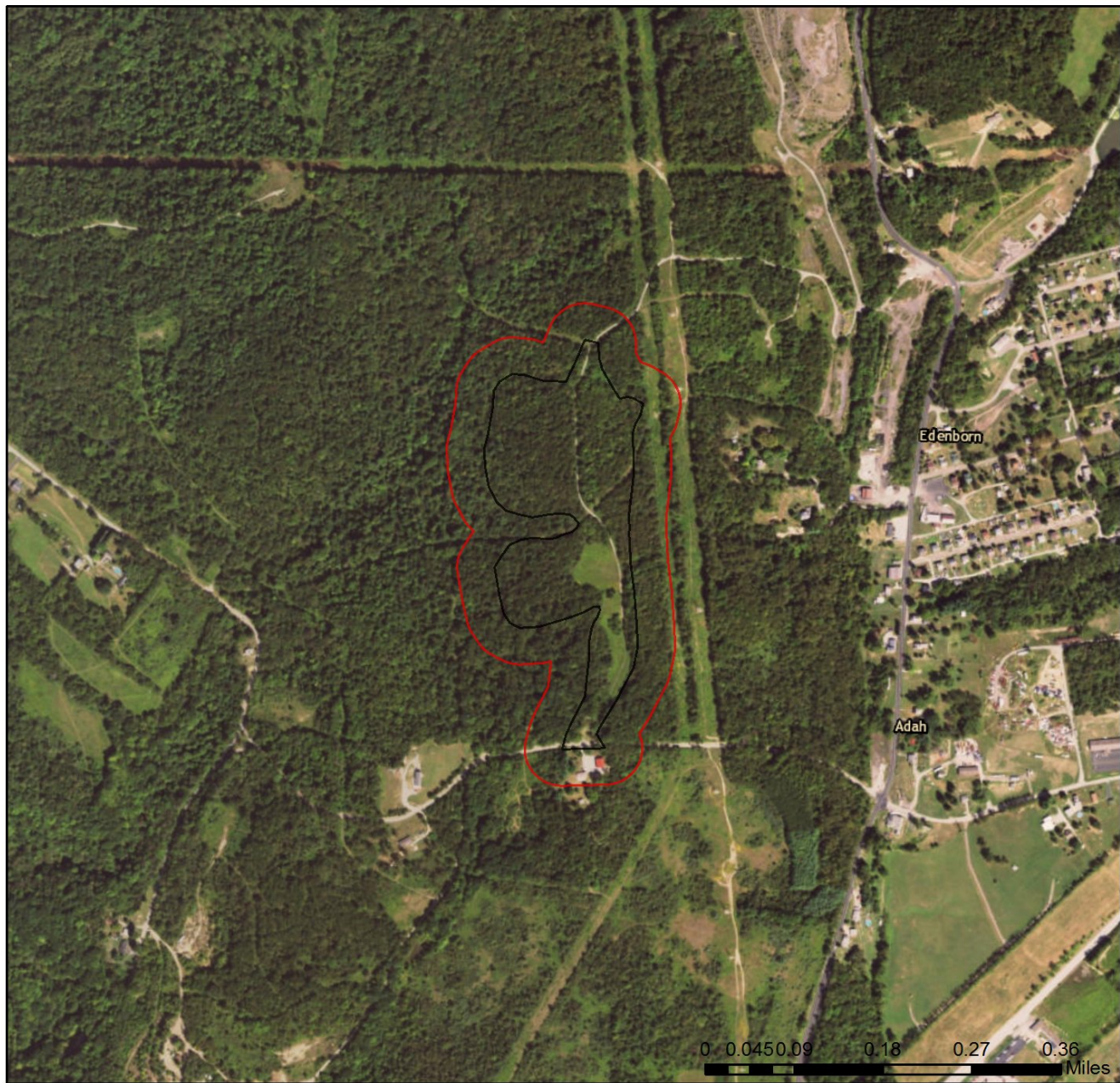

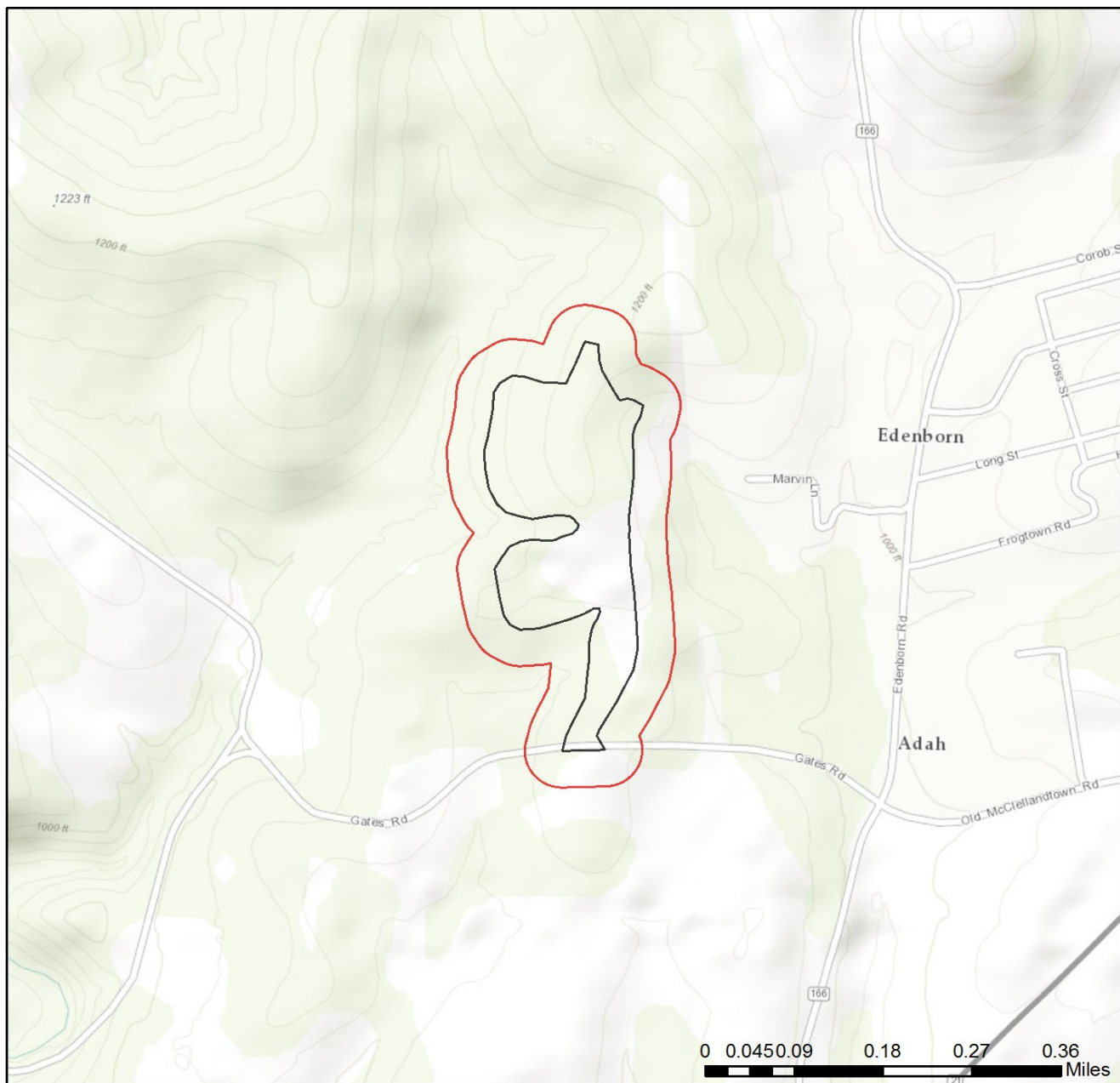

4. DEP INFORMATION
