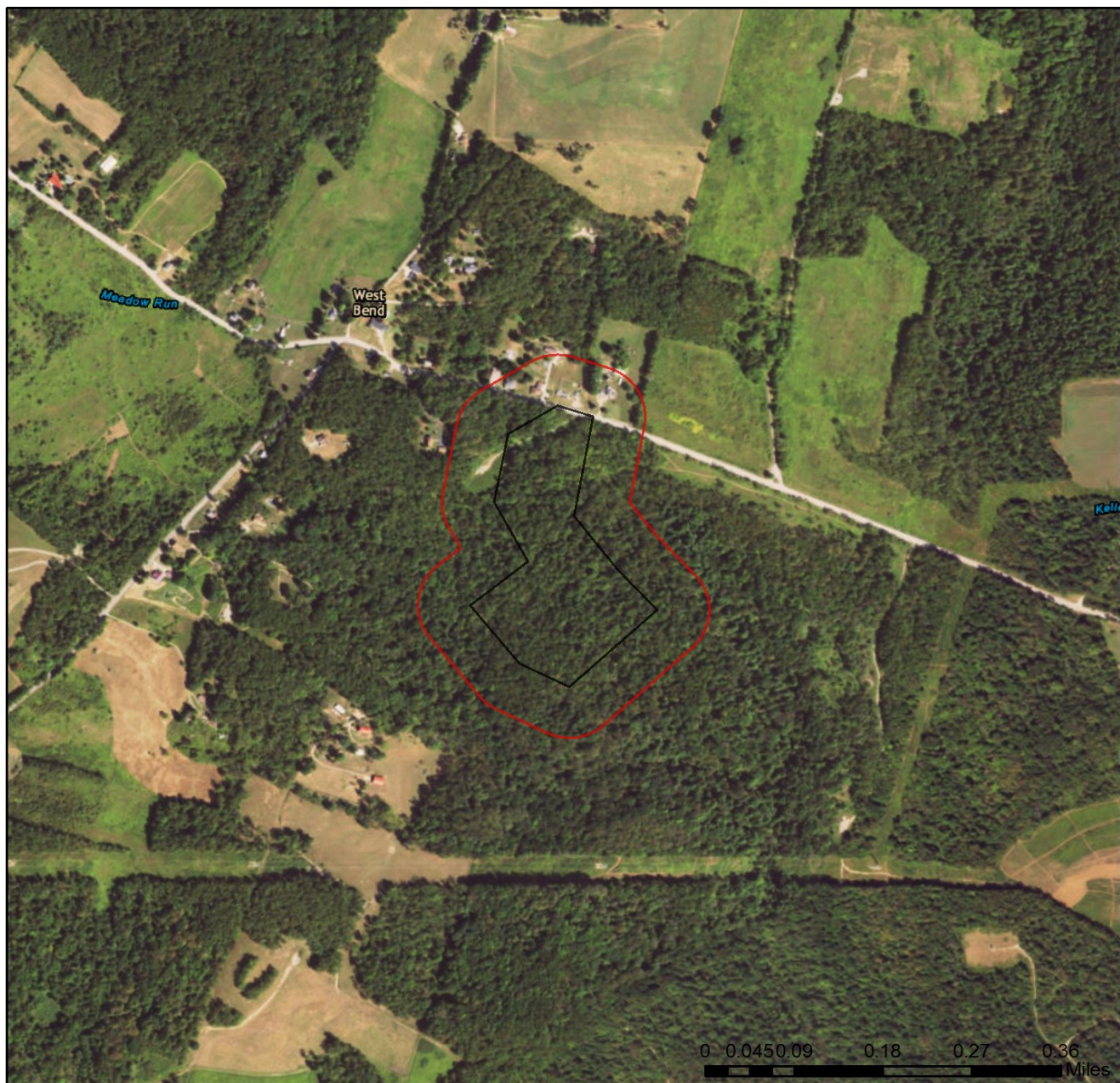

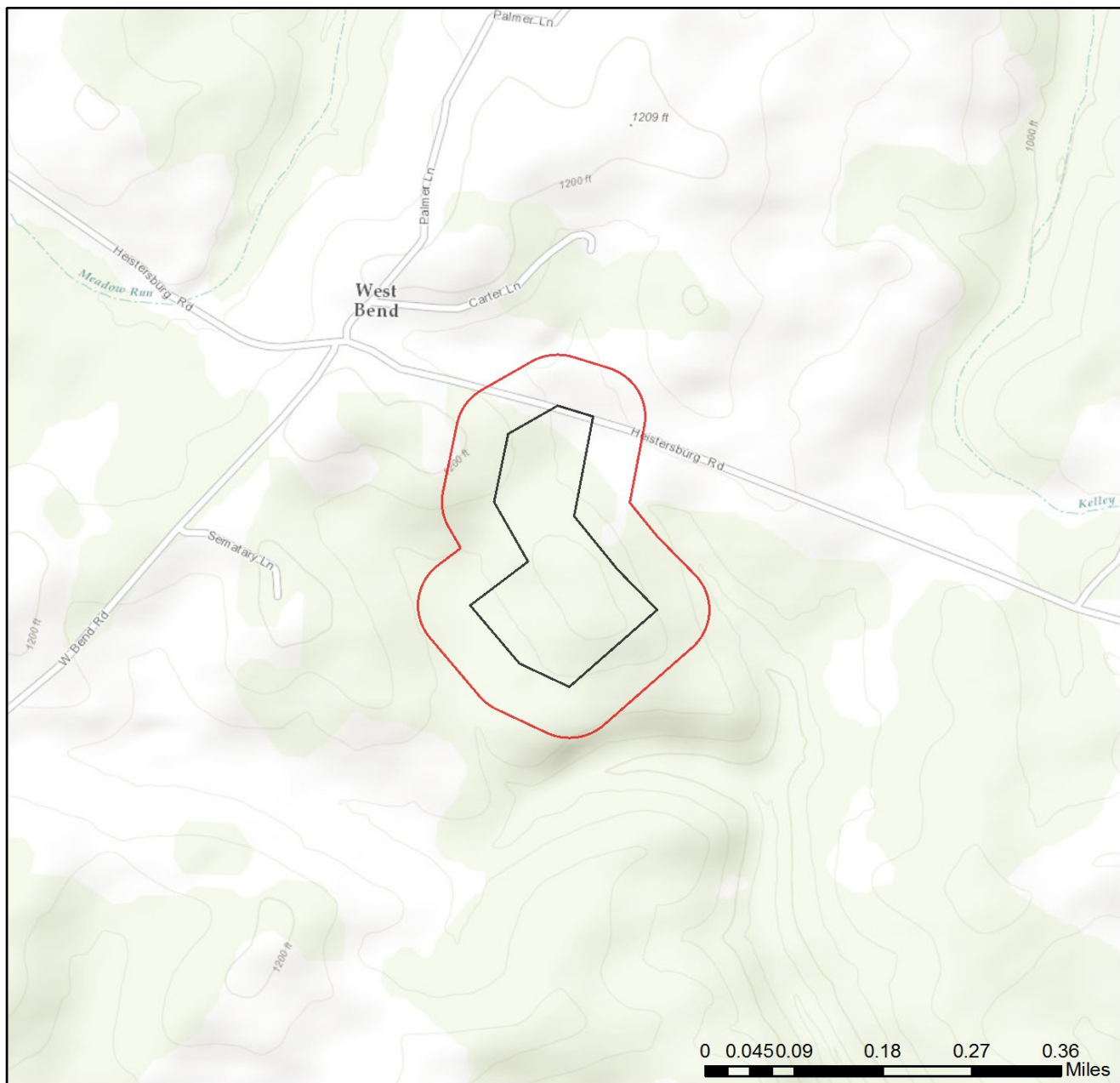

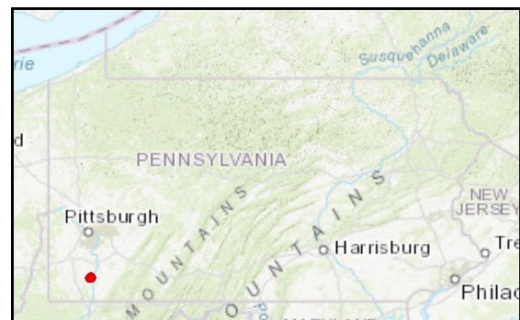

4. DEP INFORMATION
