

EQT's Proposed Alternate Method of Plugging for wells located in coal areas.

1. In lieu of venting requirements of 78.92 or 78.93 relating to wells located in coal areas, EQT proposes to cement the well from total depth or attainable bottom to surface. This will meet the requirements of 78.91H regarding cementing solid from the total depth or approved attainable bottom to surface which is superior to a gel/cement sequence in coal area wells and eliminates the need for the vent.
2. EQT will cement the well from total depth or attainable bottom to surface with Class A cement to stop the vertical flow of gas or fluids to surface within the wellbore.
3. EQT will reclaim and set plugging monument according to PA DEP regulations after the well is plugged.

6. Top off well to surface with solid cement as needed.
7. Install below grade plugging monument at least 3' below surface with API#, company information and date plugged.
8. Rig Down, move off.
9. Restore well site and access road according to PA DEP regulations.
